

We agree with the recommendation from the Grand Jury and on January 12, 2017 we made the following changes to our webpage:

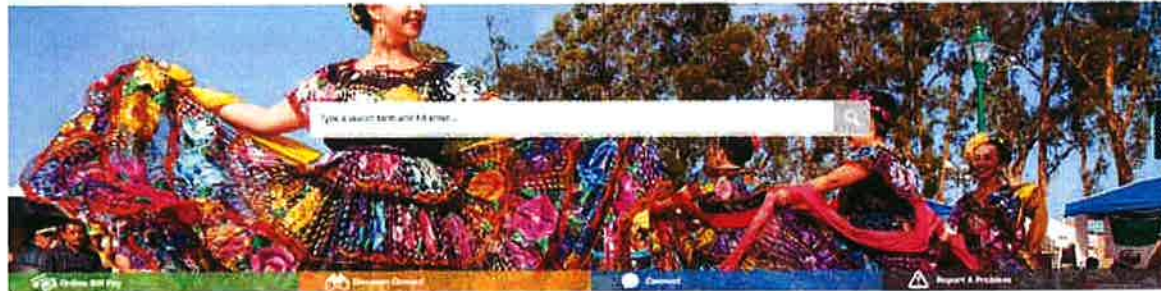
- Political Campaign Disclosure documents are now available on the City's homepage (see attached).
