1. Question: How detailed does the financial statement need to be?

Answer: County of Venture requires the Profit & Loss Statement.

2. Question: Does our fabrication subcontractor need to provide financial

statements?

Answer: No, the subcontractor does not need to provide financial

3. Question: Item e. References. Museum projects often take many years to

complete. Can we provide reference for projects completed in

the last 5-6 years?

4. Question: Do you have floor plan for the exhibit space? Locations of doors,

openings, windows, ceiling lighting and electrical outlets?

Answer: Floor plans attached. Please focus on the "Minerals" room

between "Storage" and "Fossils." The room's dimensions are exactly 10' X 16' with a ceiling of 9'. There are some 40" deep cabinets on the "Fossil" end which can be removed. The 2 doorways are standard 29" wide and 79" tall. The door on the "Fossil" end is 27" in from the inside wall (the wall with the

"Climbing Wall" on the opposing side.")

Current ceiling lighting is 1 track lighting unit with 3 fixtures.

There are at least 2-3 outlets in the room. (Difficult to determine

without moving heavy current cabinets in room.)

No windows.

The walls and ceiling will be patched and painted.

5. Question: Exhibit Fabrication. What is the color and material of the basic

Answer: Please refer to Exhibit C.


9. Question: If there are no elevations, can I get an accurate height
