

Religious Exemption for COVID-19 Vaccination/Booster

Any County employee may submit a Religious Exemption request for COVID-19 vaccinations. Note that as required by the California State Public Health Officer Order, all workers who provide services or work in a hospital, clinic, or other healthcare facility, were required to have their first dose of a one-dose regimen series (Johnson and Johnson [J&J]/Janssen) or their second dose of a two-dose regimen (Pfizer-BioNTech or Moderna or vaccine authorized by the World Health Organization) by September 30, 2021. Effective March 1, 2022, vaccine booster shots are mandatory for all fully vaccinated healthcare workers who have had a six-month period elapse since their second Moderna/Pfizer vaccine or a two-month period elapse since their J&J vaccine. Healthcare workers who are booster shot eligible (the appropriate time has elapsed since their last vaccination shot) must obtain a booster shot by March 1, 2022, as a condition of work.

As part of the order, workers whose religious beliefs prohibit them from receiving a vaccination may request an exemption from the requirement. However, workers who are exempt from the vaccination requirement will instead be required to submit to COVID-19 testing either weekly or twice weekly depending on the type of facility to which the worker is assigned.

Employees wishing to claim a religious exemption from the COVID-19 vaccination requirement must complete and submit the attestation below. Upload this completed form using the VCHRP Employee Self Service Page.
