### AMERICA'S JOB CENTER OF CALIFORNIA

- The America's Job Centers of California were created by the Workforce Innovation and Opportunity Act (WIOA). AJCCs and American Job Centers are located throughout the United States.
- The AJCCs in Ventura County operate under a consortium model with AFS and the State EDD, Workforce Services.

### AJCC PROGRAM SERVICES

• The America's Job Center of California offers access to employment and career resources to help adult and youth job seekers choose and pursue careers; access community resources and access job training and education resources. Services available to job seekers in English/Spanish at no cost to our customers.

### AJCC PROGRAM SERVICES (CONT'D)

#### WIOA requires access to mandated partner services:

"Bricks" or "Clicks" or warm hand-off to:

- Veterans services, Salvation Army, Career Services (WIOA-Title I), EDD-Wagner-Peyser; Migrant Seasonal Farmworker; Farmworker Resource Program, Unemployment Insurance; Dept. or Rehab; Adult Education and Community College; CalWORKs and, Senior Employment Program.
- Employer Services include: Targeted Recruitments; job referrals; applicant screening; job interview room; and referral to other services.

### AJCC SERVICES ELIGIBILITY

- The America's Job Center of California (AJCC) is your one-stop for workforce services, providing a broad range of no-cost employment, training and employment resources for job seekers.
- No eligibility required to access a wide range of Basic Career Services such as:
  - Job seeker workshops;
  - Resume building, interviewing help;
  - Computer, printer, and fax machine use;
  - On-site Child Waiting Room while you look for a job;
  - Job listings and employer information;
  - Career research tools
  - Online learning resources

#### **CHALLENGES & NEEDS**

- Job seekers with significant barriers to employment
- Additional partners onsite to address barriers/unmet needs of the population:
- Composition of workforce in need of training:
  - Low educational achievement levels and limited English communication skills;
  - Local labor market wages not keeping up with cost of living in Ventura County;
  - Behavioral/mental health issues requiring additional support from partners;
  - Limited funding and/or funding targeted to specific populations;
  - Increase community knowledge/awareness of the AJCC system.

## HAS- ADULT & FAMILY SERVICES – EMPLOYMENT & CAREER PROGRAMS (WIOA)

The Human Services Agency's Adult & Family Services
department, employment and career services funded by the
Workforce Innovation and Opportunity Act (WIOA) enacted in 2014.
 WIOA, replaced the Workforce Investment Act of 1998 and created
American Job Centers throughout the United States. In California,
these centers are, America's Job Centers of California.

#### PROGRAM SERVICES

- Basic Career Services Self directed resources:
  - Computer access, phones, business center; certified typing test, and access to labor market information, training information, and job listings
- Individualized Services Eligible/enrolled services:
  - Case management, career guidance, development of an Individual Employment Plan (IEP), resume writing/enhancement, job search assistance/referrals; and access to support services to obtain/retain employment.

### PROGRAM SERVICES (CONT'D)

- Job Training Services Individual Training Account or On-The-Job Training (Highlights)
  - Individual Training Account (ITA):
    - Vocational training with approved training providers and assessed as appropriate;
    - Training provided in demand occupations not to exceed \$10,500;
    - Career guidance and friendly staff to help customer's achieve a successful outcome
    - Support services available based on need
  - On-The-Job Training (OJT):
    - Work-based training plan developed for you in coordination with the employer;
    - Customers learn and earn -50% of wages paid by the program up to \$7,500;
    - Ongoing support by our AE and ES during training
    - Follow up services available one year after training.

### PROGRAM SERVICES (CONT'D)

#### Follow-Up Services — Retention Services

- One year post completion of program (exit);
- Assistance finding a job should customer lose his/her during this time;
- Access to Basic Career Services (AJCC);
- Job development and job placement assistance by account executive staff;
- Referrals to community based organizations or public assistance program;
  - Note: Support Services or additional training is not available during Follow-Up Services.

#### WIOA ADULT PROGRAMS ELIGIBILITY

There are **three** criteria for WIOA individualized services (priority is given to US Veterans, Spouse to a Veteran, Low-income individuals)

#### **Criteria 1: General Requirements for all individuals:**

- Be 18 years or older
- Have proof of right to work in the United States
- Registered with Selective Service System (males born after December 31, 1959)

#### Criteria 2: Low Income Program Requirements:

- Meet the General Requirements and the Family Low Income Guidelines;
- Provide proof of family members such as Birth & Marriage Certificates;
- Show proof of all family income.

#### WIOA DISLOCATED WORKER ELIGIBILITY

There are **three** criteria for WIOA individualized services (priority is given to US Veterans, Spouse to a Veteran, Low-income individuals):

#### **Criteria 1: General Requirements for all individuals:**

- Be 18 years or older
- Have proof of right to work in the United States
- Registered with Selective Service System (males born after December 31, 1959); and,
- Laid off or terminated and receiving, eligible or exhausted unemployment benefits and unlikely to return to former occupation or industry.

## WIOA DISLOCATED WORKER ELIGIBILITY (CONT'D)

#### Criteria 1: General Requirements for all individuals:,

- Laid off or terminated <u>and</u> receiving, eligible <u>or</u> exhausted unemployment benefits <u>and</u> unlikely to return to former occupation or industry due to:
  - Company closed or had a substantial lay-off (25% or more)
  - Dependent spouse of a member of armed forces **on active duty** and whose family income is significantly reduced due to service member change in station or service connected death/disability
  - Dependent spouse of a member of the Armed Forces on active duty who has experienced a loss of employment as a direct
     result of a relocation to accommodate a permanent change in duty station of such member.
  - An individual who has been providing unpaid services to family members in the home and has been dependent on another
    family member income but is no longer being supported by that income and is unemployed, underemployed or experiencing
    difficulty in obtaining or upgrading employment.
  - Eligible for <u>TAA</u> (Trade Adjustment Act services)

#### **CHALLENGES & NEEDS**

- WIOA Regulations Performance based and demand driven;
- Composition of workforce in need of training:
  - Participants require additional time to complete training;
  - Financial support system often lacking to complete training leading to a certificate;
  - Local labor market wages not keeping up with cost of living in Ventura County;
  - Behavioral/mental health issues requiring additional support from partners;
  - Limited funding and/or funding targeted to specific populations.

## CalWORKs

WELFARE TO WORK

## Background / History

The CalWORKs (California Work Opportunity & Responsibility to Kids) program can provide cash assistance to families with children.

Certain adults in the program are required to participate in welfare-to-work activities, such as looking for a job, attending job training, working, or furthering their education, which will improve their chances for long term employment and self-sufficiency.

CalWORKs Employment Specialists help parents develop & achieve their career goals and assist with referrals to Child Development Resources (child care) so that parents can work.

CalWORKs participants are automatically eligible for Medi-Cal and may qualify for CalFresh benefits.

### Services

While you are participating in Welfare to Work activities such as looking for a job, attending job training, working or furthering your education we can assist with:

- Child Care Costs
- Transportation Costs
- Work or training related costs: books, tools and special clothing
- Referrals to other needed services

## Eligibility

The only way to know for sure if you are eligible is to apply for CalWORKs. However, some basic eligibility factors are:

- One or both parents are deceased, or
- One or both parents are physically or mentally incapacitated, or
- The principal wage earner parent is unemployed or working less than 100 hours per month, or
- One or both parents are continually absent from the home where the child is living

If these are met, cash benefits may be available to the family for the care of a needy child or children.







### BACKGROUND / HISTORY

# The Agricultural Labor Relations Act of 1975

The Act resulted in part from an agreement between unions and growers with the goal to, "ensure peace in the fields of California by guaranteeing justice for all agricultural workers and stability in agricultural labor relations."

The Act created a State agency with two parts:

- The General Counsel
- The Agricultural Labor Relations Board

#### **SERVICES**

- I. Takes and files unfair labor practice charges filed by farm workers, growers, or unions. Investigates the allegations, and resolves the charges by issuing Complaints, informal settlement agreements or dismissal of charge.
- 2. Supervises and conducts secret ballot elections at worksites where, depending on the case, workers can choose i) union representation or not to be represented by a union, ii) to change their union representation, or iii) to no longer be represented by a union.

#### **ELIGIBILITY**

All agricultural workers in the State of California are eligible.

Most often farm workers who file charges with our office allege that after engaging in activity protected by the Act, their employer retaliates against them for exercising this right.

**Protected concerted activity is** farm workers who join together and ask for changes to working conditions. A single worker who asks for changes on his/her behalf and on behalf of others can also protected.

#### **CHALLENGES & NEEDS**

- Need wide dissemination of farm workers' rights under the Act.
- Challenge language barriers; i.e. Spanish, Mixteco, Zapoteco, Triqui, Purepecha, etc...
- Challenge locating workers who often move due to work or other circumstances, and may change telephone numbers frequently.
- Challenge Fear. Due to many circumstances, many farm workers are afraid to exercise their rights on the job because they fear they will be fired. Distrust. Many farm workers fear governmental agencies.
- Need providing resources to agricultural employers through trainings of their supervisory personnel.
- Challenge agricultural employers may not know about our office or they are resistant to having a
  governmental agency talk to their supervisory personnel. Also, business demands can make it difficult for
  employers to schedule trainings.



# **Background/History**

In the fall of 2018, the Ventura County Board Supervisors approved the implementation of a new Farmworker Resource Program to reside within the Human Service Agency, with goals that Include:

- Build trust and relationships among the Agricultural Community
- Assist Farmworkers in seeking prompt resolutions to workplace issues and navigation public agencies
- Assist farmworkers to understand to understand existing labor laws protecting them
- Attract farmworkers to Ventura County as first choice destination to work in agriculture









The Farmworker Resource Program are able to provide services in Mixteco, Spanish, and English, and can help by:

- Serving as liaisons for farmworkers, employers, and other representatives within the ag community
- Providing valuable resources and information available through state, county, and local agencies
- Help to facilitate resolutions, when needed; reviewing federal, state and county laws, regulations, and policies to assist farmworkers and employers to reach collaborative solutions related to workplace conditions
- Develop educational and outreach tools for programs and laws that serve as resources for the agriculture community
