4.0 Presentation: PathPoint, Inc.

Kim Whitaker, Director Program Services, presented a PowerPoint overview of PathPoint's Workforce Innovation and Opportunity Act (WIOA) contracted Youth Services program. PathPoint has provided successful WIA and WIOA services to high risk youth since 2001 in Ventura County. Since 1964, PathPoint is a leader in employment and independent living services in five southern California counties. Ms. Whitaker introduced three Youth Specialists, Pierrette Authier, Jessica Gallardo, and Marixza Juarez. The Youth Specialists each provided program insights.

PathPoint was successful in the recent County RFP to be selected along with the Boys and Girls Clubs of Greater Oxnard and Port Hueneme (BGCOP), to provide youth services to out-of-school youth ages 16-24. WIOA eligibility requirements include barriers such as low income, basic skills deficient, pregnancy/parenting, disability, foster, probation, or homeless. PathPoint serves all of Ventura County except Oxnard and Port Hueneme, which is served by BGCOP. PathPoint expects to enroll more than 90 youth in the WIOA PY 17-18. WIOA mandates that youth participants receive as many as 14 program elements such as paid internships, alternative secondary school and drop-out recovery services, supportive services, and follow-up services after exit. PathPoint is expected to meet high levels of four successful outcomes which include

employment reported in 2nd and 4th quarters after program exit, Median earnings reporting, credential attainment, and measurable skills gain.

Committee members had thoughtful discussion and several questions for the PathPoint team. Committee Members provided resource suggestions for PathPoint's program consideration including paid apprenticeships via local labor unions, entrepreneurial skills training available from Economic Development Collaborative-Ventura County, Aspire 3 K12 Entrepreneur Program, and Young Entrepreneurs Academy – Oxnard Chamber of Commerce. Committee members expressed encouragement and gratitude to PathPoint for their continuing efforts to offer high quality services for high risk youth.

5.0 WIOA Implementation and Development

Patrick Newburn provided Committee Members information on the new WIOA 14 Program Elements and the 5 performance indicators (outcomes). The program elements and performance indicators are employment and training services offered to adult, dislocated worker, and youth participants. Committee members agreed to use this information to conduct the oversight necessary to ensure that providers are effective and fulfilling the intent of WIOA and the WDBVC Regional and Local Plans. Program providers report their services and outcomes into the automated management system CalJOBS, and reports will be generated for oversight by the Committee at periodic intervals.

Committee Members reviewed the Client Centered Oversight/Monitoring Discussion Notes from the March 1, 2017 meeting.

Patrick Newburn announced that the May Meeting is cancelled.

Committee Accomplishments

In support of the WDB's *Ventura County Regional Strategic Workforce Development Plan 2013-2017*, WDB Programs Committee accomplishments included:

- WDB Established new standing committee, Programs Committee, with responsibility for oversight of all WIOA Title I programs including Adult, Dislocated Worker, and Youth. Members learned that the new Committee has a more expanded role than the previous Youth Council which was disbanded after June 30, 2016, in order to provide for WIOA programs oversight. In accordance with WDB policy for Non-WDB members on the Programs Committee, Non-WDB Members were required to submit new committee membership applications and resumes in order receive recommendation from the WDB Membership Committee for approval by the WDB
- Members were required to learn committee roles and responsibilities. The principal role of oversight was defined by members as separate from the role of monitoring
- Reviewed the WIOA youth enrollment requirements for ages 16 to 24 years of age, and in particular the requirements for out-of-school youth
- Discussed youth-related programs and services in Ventura County as described in presentations on the 100% Out-of-School Youth Requirement; Presentations from PathPoint, Inc. and Boys & Girls Clubs of Greater Oxnard and Port Hueneme; Progress on WIOA Implementation
- Reviewed the 2016-2017 WIOA Adult, Dislocated Worker, and Youth program enrollment Quarterly Report
- Discussed and reviewed how adult and youth program providers, either directly or through partners, arrange for all 14 WIOA elements to be provided as needed by individual clients
- Discussed and studied the Adult, Dislocated Worker, and Youth , four Performance Indicators (Common Measures): Placement and Retention in Employment-Education-Training (2nd quarter and 4th Quarter After exit); Median Earnings (2nd Quarter after Exit); and Credential Attainment and Measurable Skills Gain

Youth Empowerment Program

- YEP is a federally funded program through the Department of Labor.
- We received this grant in 2004
- The purpose of this program is to provide comprehensive youth Workforce Innovation and Opportunity Act (WIOA) services to out-of-school youth in Ventura County between the ages of 16-24, to those living in Oxnard and Port Hueneme.



Who is eligible?

- Youth, age 16-24, who is not attending school and meets at least one of the following criteria:
 - School dropout
 - Within compulsory school age, but has not attended for at least the most recent school year calendar quarter
 - Recipient of a secondary school diploma or its recognized equivalent who is low-income **and**
 - Basic skills deficient **or**
 - English language learner
 - Subject to the juvenile justice system
 - Homeless, a runaway, in foster care or aged out of foster care, or in an out-of-home placement
 - Pregnant or parenting
 - Disabled
 - Low-income and requires additional assistance to enter or complete an educational program or secure employment

YEP Goals

- Assistance youth obtaining High School Diploma, G.E.D. or HISET?
- Assistance youth obtaining employment and retaining?
- Assistance youth enrolling into Vocational Training or College?





WHAT WE DO...

- Participants receive 40 hours of Job Ready instruction that teaches them resume writing, mock interviewing, job searching etc.
- Set an individualized plan which will guide the students to attain their goals of employment or education
- Each youth has an Academic and Career Advisor assigned to assist in providing wrap around services during active and follow up phase

Subsidized Employment

- 125 hours of work experience @ \$11/hr

- They treat it as if its their job because potentially they can get hired on.



Vocational Training

- Students interested in vocational training undergo an essay and interview process.
- Those selected receive funding to pay for their vocational course and materials.



College and Career Center

- The College and Career Center offers many resources to promote higher education and assist our youth in attaining employment. Our College and Career Center consists of:
 - Computers so youth may research schools, careers, and current employment opportunities
 - Compilation of job applications from local employers and a job board
 - Job interviewing and job searching techniques
 - Information on financial aid and scholarships
 - Weekly Job Listing



Another Great WDB Success Story

Type of Customer: Youth



Brenda Castellanos

The Challenge:

A high school graduate, Brenda was stalled in her efforts to develop a path toward her academic and career goals. She had trouble adjusting to her parents' divorce and was unable to find the guidance she sought at home. Brenda took her first step forward by enrolling in the Out of School Job Readiness Program.

The Solution

From the first day of the Job Readiness Workshop, Brenda was very shy and kept to herself. Many of her fellow participants encouraged her to speak up and participate, but she stayed in her shell. During the course of the workshop, Brenda found her voice and began to participate—even more than the others. She asked questions and helped her peers when they needed assistance. When the Job Readiness Workshop ended, she enrolled in community college. Brenda continued to utilize the Boys and Girls Club College and Career Center to develop a résumé and practice her interviewing skills.

The Outcome:

Her efforts paid off; Brenda was hired by both Target and the very Boys and Girls Club After School Program where she started her journey. She is now more outgoing and confident and communicates with ease. Staying on track to achieve her academic goals, Brenda plans to enroll in the spring semester at Ventura College. With her perseverance and hard work, Brenda is off to a great start in her new life.

Another Great WDB Success Story

Type of Customer: Youth



The Challenge:

Antonio comes from a low-income family, and his parents are divorced. He lives with his mother and two siblings. He was a student at Oxnard High School when he learned about the Job Readiness Workshop and the Youth Empowerment Program (YEP) at the Boys and Girls Club. Antonio knew that enrolling in the program would help him prepare for college and join the workforce.

The Solution:

During the workshop, Antonio learned how to create a résumé and write a cover letter, as well as to search and apply for jobs online. While in the YEP program, Antonio received many services and assistance. The program paid for his driver's license and purchased clothes for him to wear to job interviews. Because of his exceptional commitment and performance in the Job Readiness Workshop, he was selected to take part in a subsidized employment program. In this program, Antonio had the opportunity to complete 125 hours of paid work at Smart & Final.

The Outcome:

Antonio completed his hours, obtained his diploma from Oxnard High School, and was offered a permanent job at Smart & Final. He is now working and attending Ventura College and hopes to transfer to Chico State University in two years. Antonio also speaks of becoming a police officer after obtaining his bachelor's degree.

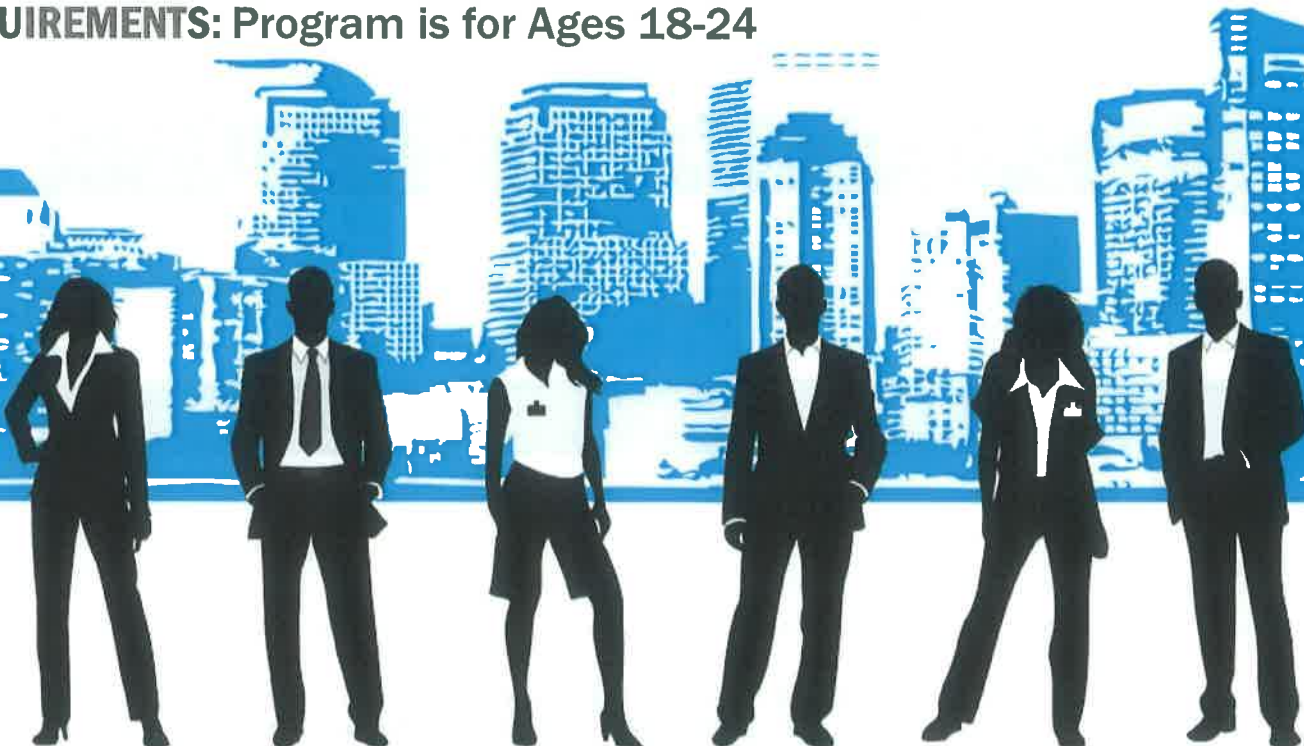
